LAND PRIDE 606 NO-TILL DRILL RENTAL AGREEMENT

Warm Season No-Till Drill with the following specifications:

Transport width 8'6" working width 6', Small Seed Box (1.44 bushel); Native Grass Box (6 bushel); and Main Box Capacity (12 bushel). Gross weight 2,700. **A 40 HP minimum** tractor is needed in the field. **Tractors must have universal hydraulic hook-ups to use the no-till drill.**

**Fees**

- Rent \$10.00/acre (\$50.00 deposit/minimum)
  - Cleaning Fee \$100.00
  - Penalty for using fertilizer in seed box \$100.00 (future rental will be denied)
  - Late return of drill \$50.00/day after 3 days
  - Late payment fee 1.5% monthly after 30 days – After 90 days forwarded to Scioto County Prosecuting Attorney
1. I assume full liability and responsibility for damages to or caused by the equipment (beyond normal wear and tear) from the time I obtain it until I return it to the office. I will inspect the equipment and will notify district as to any problems with the equipment.
  2. I certify that I have liability insurance on the vehicle used to transport the equipment, and this insurance also applies to the equipment being towed with the vehicle.
  3. I agree to indemnify and hold harmless the District, and the County of Scioto, Ohio their agents, employees or any other person against loss or expense including attorney fees, by reason of liability imposed by loss upon the District and County, for damages because of bodily injury, including death at any time resulting from, sustained by any person or persons, or on account of damage to property arising out of the transportation or the use of the equipment rental from the District.
  4. The Cooperator is responsible for ensuring the seed rate is adequately set for the desired outcome prior to planting. The District is not responsible for under-seeding or over-seeding.
  5. The District is not responsible for planting failures due to Cooperator's improper use, calibration, or depth settings, or extreme weather conditions (excessive rain/flooding, drought, heat), or insufficient germination due to improper timing of planting outside of USDA-NRCS Appendix A – Seeding Tables found in the Field Office Technical Guide or the OSU Extension Ohio Agronomy Guide.
  6. Drill must be cleaned and greased before returning. A cleaning fee will be charged if the drill is not cleaned before returning. **Seed box and drop tubes must be blown out with air and not sprayed out with water!**
  7. All damages due to misuse or negligence on the part of the renter will be paid by the renter as determined by the District. Maintenance resulting from reasonable wear and tear will be the responsibility of the District.
  8. DO NO TURN CORNERS WHILE THE DRILL IS IN THE GROUND AS SEVERAL HUNDRED DOLLARS OF DAMAGE COULD BE DONE or IN REVERSE WITH THE DRILL IN THE GROUND TO PREVENT DAMAGE TO THE DRILL AND CLOGGING OF THE SEED DISPENSERS.
  9. I will provide transportation to and from the designated point of storage or pickup. All necessary measures will be taken to ensure the proper transport of the equipment. THE DRILL WILL BE USED DURING DAYLIGHT HOURS ONLY!!!

10. I will pick up and use the equipment in a timely manner after the District has notified me of the availability. I will have and use the drill for no more than **three (3)** days, weather permitting, or there will be a **\$50.00 a day late return fee after 3 days.**

11. The drill shall not be used in fields that contain underground objects that could damage the machine, including tree stumps and roots, rocks, or brush.
