**Stolzfus -** The tractor must be at least 60 horsepower to be used to pull the lime spreader. The lime spreader may not be used on slopes greater than 16%. Lime shall not be hauled to the farm in the spreader – the lime must be loaded into the spreader at the farm.

- 1. I assume full liability and responsibility for damages to, or caused by the equipment (beyond normal wear and tear) from the time I obtain it until I return it to the office. I will inspect the equipment and will notify the Scioto Soil and Water Conservation District (SWCD) at 740-259-9231 ext. 4 as to any problems with the equipment.
- 2. I do agree to pay for parts and labor at a rate of \$50 per hour (if it can be fixed at the SWCD) or actual cost if it must be sent to a shop to be repaired.
- 3. I agree to grease the equipment before using.
- 4. I agree to remove all material (fertilizer, lime, mud or debris) from the equipment upon completion, Failure to do so will result in a cleaning fee. **NO USING PRESSURE WASHER.**
- 5. I agree to remove bows before loading lime to prevent bending of bows, and will replace before returning the lime spreader.
- 6. I will provide transportation to and from the designated point of storage or pickup. All necessary measures will be taken to ensure the proper transport of the equipment. All of the equipment will be transported during daylight hours only!!! The lime spreader will be transported no faster than **35 miles per hour** and in accordance with the Ohio Motor Vehicle Laws and the Ohio Revised Code pertaining to transportation of farm equipment.
- 7. I certify that I have liability insurance on the vehicle used to transport the equipment, and this insurance also applies to the equipment being towed with the vehicle.
- 8. I agree to indemnify and hold harmless the District, and the County of Scioto, Ohio their agents, employees or any other person against loss or expense including attorney fees, by reason of liability imposed by loss upon the District and County, for damages because of bodily injury, including death at any time resulting from, sustained by any person or persons, or on account of damage to property arising out of the transportation or the use of the equipment rental from the District.
